Annual Meeting.

Nominations will also be accepted from the floor during the Annual Meeting. Ballots will be distributed at the Annual Meeting. The Board urges all Owners to attend the Annual Meeting as a quorum is required to conduct the annual election and other official business. If an Owner is not able to attend the Annual Meeting, kindly mark, date, sign and promptly deliver your Proxy to Jones & Jones, any Board Member or Villa Owner who will attend the Annual Meeting to vote on your behalf. The Proxy is revocable and will not affect your right to vote in person in the event you attend the Annual Meeting.

Roof Rplacements

The Association hired Norton Sons Roofing Co., Inc. to replace 6 roofs this fall to begin in the next few weeks.

Norton Sons Roofing provides a 1-20 year (non-prorated) warranty on material and labor coverage and years 21-25



(prorated) material and labor coverage. The Board is continuing to work on a list of which roofs should be replaced in 2011, 2012, etc.

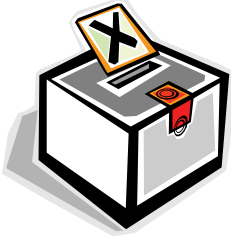
Property Management Information.

Annual Meeting



Our Annual Meeting to elect Board members is on Wednesday, November 10 at 7:00 pm in the Clubhouse. In October, Northwest Property will send the Annual Meeting notice along with the 2011 budget to all owners.

Roof Repairs.

Cost Roofing was awarded the contract to replace the roof and gutters on building 16 (2S621). The old roof and gutters are to be replaced with architectural shingles and oversized gutters in October.

Garbage Pickup.

The August newsletter requested homeowners not to place garbage and recycling bins outside any earlier than sunset of the night prior to pick up. Homeowners are reporting that bins and garbage are still out earlier than sunset. **If there is food waste in the bags, don't set the garbage out until the day of pickup.** Garbage bags with food attract animals (raccoons and skunks). Garbage out early and broken bags detracts from Emerald Green. *Thank you for helping us to keep Emerald Green attractive.*

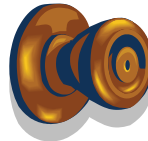


Past Due.

Safety Tip Re: Entry Doors.

Please be sure to lock the door to your unit's whenever you leave—even if you are simply taking your dogs for a walk, running over to a neighbors, or going for a walk. Emerald Green has to provide keys to vendors (ComEd, City of Warrenville, Northwest Property, janitorial service, fire alarm service, Recreation board, etc.) access to all of the entry doors to the buildings. Please keep this in mind when you leave your home.



If the entry door to your building does not automatically close or the lock does not catch, call or email Northwest Property to repair the door.

Space Heaters and Water.

The space heaters in the common hallways will be turned on in November and at the same time the outside water will be turned off for the winter.

Proof of Liability Insurance.

Proof of liability insurance must be submitted to Northwest Property Management every year as your property insurance policy renews. Be sure your insurance company has that information and complies. 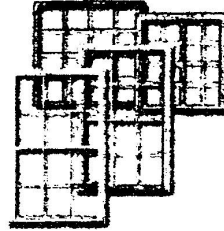
